SCRAP TIRE SURFACE MATERIALS GRANT FUNDS AVAILABLE

The Missouri Department of Natural Resources (DNR) Solid Waste Management Program recently announced the availability of funds under the Scrap Tire Surface Material Program. Under this program, material derived from scrap tires is used as a soft surface for facilities such as playgrounds, running tracks, walking trails, and the like. Again this year, DNR has established two separate classifications of projects. In the “Non-playground” category are projects such as running tracks, walking trails or equine/livestock stalls/riding areas. Projects proposing to use mats or pour-in-place materials are eligible to apply for up to \$50,000, and projects requesting loose bulk material will be eligible for up to \$25,000. In the “Playground” category, projects proposing to use mats or pour-in-place material are eligible for up to \$20,000. Projects proposing to use loose bulk material will be eligible for up to \$10,000. Only one application will be accepted from any applicant.

Once again, for the 2014 round, no local match is being required. Provision of matching funds will, however, strengthen an application by up to 15 points in the evaluation process. Also, repair of projects done under prior grants will not be an eligible activity. Prior recipients of funding under this program are not eligible unless the proposed project is an expansion of an area previously funded.

Public and private schools, parks, non-profit day care centers, other non-profit organizations, and governments other than state agencies are eligible for funding. Funds will be used to support delivery and installation of materials on surfacing projects approved by DNR. Due to Americans with Disabilities Act requirements, preference will be given to mat and pour in place projects. There are also local content requirements that will need to be met.

Your staff reviewed the four-page application form and found it reasonably straightforward.
