Chairman Koeper requested a motion to approve the agenda. Commissioner Ruzicka moved to approve the agenda, Mr. Welch seconded, motion carried.

Chairman Koeper requested a motion to approve the minutes. Commissioner Kater moved to approve the minutes, Commissioner Kemp seconded, motion carried.

Mr. Christian spoke on the status of the Cape Girardeau/Jackson MPO. They have a new vendor for online TIP tool. They are working on a Safe Streets for All safety study and intersection safety preliminary studies. RPC is doing mapping admin for the MPO. The MPO will be passing a new work plan in May/June.

Mr. Christian went over handouts for Blueprint for Safer roads. The packets include Year to Date and 2023 Final reports. Fatalities are down.

Mr. Christian discussed the upcoming prioritization process. He will be sending out online submission forms soon. Mr. Christian wants to make sure when a member of the RPC comes to meet with your community that you have a project list with you. The July meeting will be the finalization of the prioritization list for MoDOT's next STIP and also unfunded needs list. Mr. Christian said these can and should include: small/short term projects (5 years), large/long term projects (10+ years), and projects you may not have plans for yet but have an idea they are needed. Mr. Tanz added that the Unfunded needs list is like a "golden list" for legislature looking at other funding opportunities.

Report From MoDOT Representatives:

<u>Chris Crocker</u>: Many projects underway or starting. Chester Bridge is moving along there are cameras you can watch at the MoDOT website of the progress. Pier 4, 5, and 6 foundations on the Missouri side are done. Six of the Eight drilled shafts are complete and 8 more on the Illinois side are needing done. Tenative calls for TAP March 1- April 26, TEAP Aug 1- Sept 12, and BRO Oct 1- Nov 12.

<u>Joe Killian</u>: It is STIP season, starting to compile a list of FY25-FY29. Be proactive in submitting. Mr. Killian met with most urban areas to update urban boundaries. There are some of these that were not approved. He will be setting up meetings to discuss this list.
